## **Summary**

Under general supervision of a Bureau Director – Environmental Health, independently conducts sanitation inspections of eating establishments, commercial facilities, and public buildings. Inspects onsite sewage disposal and water systems to determine compliance with ordinances and laws designed to protect the health and safety of the public. Responds to and investigates complaints related to public health. Conducts public education training related to environmental health. May be assigned to work in multiple functional areas or exclusively to one, as determined by the Division Director – Environmental Health.

#### **Essential Functions**

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Inspect food establishments in assigned areas using established protocol; inspect temporary
  food establishments and temporary mass gatherings, as assigned; issue written orders and/or
  close establishments for non-compliance, as needed.
- Perform physical inspections of public pools; provide ongoing consultation with owners and
  operators regarding public pool water chemistry and water quality; collect bacteriological
  samples for laboratory analyses from public swimming pools in assigned geographic areas;
  measure pH and disinfectant levels to determine compliance.
- 3. Inspect school facilities, tanning salons, body art facilities, and used oil collection sites for sanitation and health code compliance.
- 4. Perform pre-opening inspections for food establishments and public pools in coordination with a Program Manager – Environmental Health; assist Program Manager – Environmental Health with performing plan reviews.
- 5. Teach Food Handler classes and educational classes, as assigned.
- 6. Respond to and investigate complaints as assigned by a Bureau Director Environmental Health.
- 7. Provide education and technical support to the public about environmental health regulations and other issues.

- 9. Determine suitability of onsite wastewater disposal systems; review and approve third party designs of onsite wastewater disposal systems; perform onsite evaluations, as needed.
- 10. Determine United States Department of Agriculture (USDA) soil classifications; perform soil evaluations, as needed.
- 11. Determine functionality of existing onsite wastewater systems and drinking water quality; conduct loan clearance investigations.
- 12. Consult on the installation of septic systems; inspect for correct installation, proper use of materials, and layout.
- 13. Perform Underground Storage Tank (UST) inspections including installation, closure, and leak inspections of active and inactive sites.
- 14. Determine compliance with drinking water standards for private wells; collect water samples, as
- 15. Determine compliance with public drinking water standards; perform sanitary surveys of public drinking water systems; prepare and submit public water system reports and recommend improvements and repairs.
- 16. Represent the Health Department on various committees and boards.
- 17. Understand and represent the Health Department in enforcement of environmental health rules and regulations.
- 18. Respond to public health emergencies as required by department or division administration; carry provided cellular phone or other emergency communication devices during all work hours and at all other times when unavailable by phone.

#### **Supervisory Responsibility**

This position has no direct supervisory responsibility but does serve as a coach and mentor for other positions in the department.

#### **Work Environment**

Work is regularly performed in environmentally controlled buildings but is performed outdoors periodically and occasionally in hot, cold, or inclement weather. Work may expose incumbent to conditions such as fumes, noxious odors, dusts, mists, gases, and poor ventilation and to contagious or infectious diseases or hazardous chemicals. Work occasionally requires the use of protective devices such as masks, goggles, and gloves. Work occasionally exposes incumbent to equipment or tools and other environmental elements that have the potential to cause bodily injury. Work occasionally exposes the incumbent to high-stress situations including contact with clients and/or the public in uncomfortable, confrontational, and emotionally charged circumstances. This role routinely uses standard office equipment such as a laptop, desktop, smartphone, photocopiers, shredders, and filing cabinets. The noise level in the work environment is usually moderate. The incumbent may be required to drive Utah County owned vehicles in the course of conducting County business and must abide by the Utah County Vehicle Policy.

#### **Physical Demands**

While performing the duties of this job, the employee is required to use manual dexterity to handle, feel, and operate objects, tools and controls, and reach with hands and arms. The employee is frequently required to stand, talk, and hear. The employee works for sustained periods of time maintaining concentration and attention to detail and may be required to ascend or descend ladders, ramps, or rough terrain. Specific vision abilities by this job include close vision, ability to adjust focus, and ability to distinguish between shades of color and patterns. The employee is required to type, file, and lift supplies up to thirty (30) pounds and may be required to lift or otherwise move objects weighing up to fifty (50) pounds. The employee frequently drives a motor vehicle.

#### Position Type / Expected Hours of Work

Incumbent must work forty (40) hours each week to maintain full-time status. There may be availability to work out a flex schedule ahead of time that works for both the County and the employee. Occasional evening and weekend work may be required as job duties demand, and incumbent may be contacted at any time during emergency situations and during off hours as required by department policy.

#### Travel

Travel is primarily local during the business day, although some out-of-area and overnight travel may be expected, up to five (5) percent.

- 1. Bachelor's degree from an accredited college or university that includes thirty (30) credit hours in the natural sciences or a closely related field.
- 2. Three (3) years of experience as a licensed Environmental Health Scientist.

#### **Preferred Education and Experience**

1. Preference may be given to applicants who possess multiple certifications in an environmental health field and/or certifications applicable to position.

#### **Additional Eligibility Qualifications**

- 1. Applicants must be licensed through the State of Utah as an Environmental Health Scientist.
- 2. Applicants must obtain and maintain certifications in an environmental health field and/or certifications applicable to position.
- 3. Applicants must possess a valid driver's license and obtain a valid State of Utah driver's license within sixty (60) days of employment.
- 4. Selected applicants will be required to submit to a pre-employment drug screen and background check.
- 5. Selected applicants shall be strongly encouraged to receive immunizations according to the Center for Disease Control and/or County Health Department policy.

### **Career Ladder Advancement**

For career ladder advancement from a lower classification level of this series to a higher one, there must be funding in the budget and the employee must:

- 1. Possess the required licensure and certifications of the higher classification level.
- 2. Meet the education and experience requirements and the class characteristics of the higher classification level.
- 3. Receive written recommendation from the department head.
