Summary

Under general guidance and direction of the Evidence and Crime Lab Supervisor, supports the forensic evidence collection and processing function of the Utah County Sheriff's Office. Performs and supports all types of crime scene processing and evidence collection but may be assigned a specialized area of focus and serve as a lead in that area. This role requires advanced knowledge, advanced skill, and the ability to lead and train others in a wide array of forensic techniques and processes.

Essential Functions

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- 1. Ensure appropriate protocols are followed to prevent crime scene contamination and destruction of evidence.
- 2. Locate, develop, photograph, and lift latent fingerprints at crime scenes and from evidence collected and brought to the forensic lab for processing.
- 3. Prepare fingerprints found on various types of evidence for submission to, and comparison by, the Automated Fingerprint Identification System (AFIS); perform manual side-by-side comparisons of ineligible prints.
- 4. Collect, preserve, examine, analyze, and process digital evidence using specialized investigative tools without altering original evidence.
- 5. Access digital evidence in deleted, hidden, encrypted, corrupted, and protected electronic files to expose and recover digital evidence.
- 6. Photograph crime scenes, traffic accidents, and other law enforcement related incidents.
- 7. Produce photographic reproductions of crime scenes, evidence, victims, and suspects.
- 8. Document traffic and crime scenes; use technical measurement equipment, as needed.
- Prepare specimens for laboratory analysis; prepare media, solutions, reagents, and other technical laboratory processes and procedures; conduct tests and examinations; evaluate results.
- 10. Prepare detailed and comprehensive reports of findings for submission to law enforcement.

- 11. Testify in court on matters pertaining to crime scene investigation techniques, fingerprints, latent print identification, photography, or other forms of physical evidence identification.
- 12. Provide technical assistance to the prosecution; assist in developing case arguments and preparing evidence for court presentation.
- 13. Provide expert assistance to detectives and other law enforcement personnel related to the documentation and processing of crime scenes and the collection and preservation of evidence.
- 14. Receive, maintain, release, and dispose of evidence in accordance with evidence-handling procedures and best practices.
- 15. Partner with state, county, and city law enforcement agencies for high-profile or complex cases, as requested.

- Knowledge of photographic lighting, distortion and proper lens and camera selection
- Skilled in reading, writing, and verbal communication
- Skilled in using computers, including graphics/digital imaging and software applications as they
 relate to forensic applications and processes
- Skilled in using photographic and video equipment and techniques
- Skilled in fingerprint lifting technology, including chemical processing, laser printing, super gluing, dusting, and fuming
- Ability to establish and maintain cooperative relationships with those contacted in the course or work activities
- Ability to effectively testify as an expert witness in court
- Ability to continually learn new technologies and methodologies
- Ability to work carefully and methodically, even when under severe time constraints
- Ability to work under minimal supervision
- Ability to work cooperatively in a team environment
- Ability to exercise appropriate judgment to establish work priorities and methods
- Ability to maintain composure and professionalism despite exposure to disturbing images, crime scenes, and information
- Ability to lead and train others in a wide array of forensic techniques and processes

Supervisory Responsibility

This position has no direct supervisory responsibility but does serve as a lead to some and as a coach and mentor for other positions in the department.

Work Environment

Work is performed in an environmentally controlled office or laboratory but is regularly performed off-site in a variety of settings. This role is regularly exposed to information, crime scenes, and images that are stressful and disturbing. Work is occasionally performed for sustained periods outdoors including in hot, cold, or inclement weather. The employee is regularly exposed to fumes, noxious odors, airborne particles, and toxic or caustic chemicals and is occasionally exposed to bodily fluids and contagious or infectious diseases. This employee regularly uses personal protective equipment (PPE) such as body armor, masks, eye shields, and gloves. This employee is exposed to possible bodily injury from working on or transporting equipment, tools or machinery, and to potentially hostile, unknown or dangerous situations. The incumbent may be required to drive Utah County owned vehicles in the course of conducting County business and must abide by the Utah County Vehicle Policy.

Physical Demands

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

While performing the duties of this job, the employee is required to use a high degree of manual dexterity to handle, feel, and operate objects, tools and controls, and reach with hands and arms. This employee is frequently required to stand, talk, and hear and is occasionally required to bend, crawl, and ascend and descend ladders, scaffolding, poles, etc. While performing the work, the employee regularly lifts up to twenty-five (25) pounds and occasionally lifts or moves objects weighing up to fifty (50) pounds. Specific vision abilities required by this job include close and color vision, ability to adjust focus, and ability to distinguish between shades of color and patterns. The employee regularly drives a motor vehicle.

Position Type / Expected Hours of Work

Incumbent must work forty (40) hours each week to maintain full-time status. There may be availability to work out a flex schedule ahead of time that works for both the County and the employee. Occasional evening and weekend work may be required as job duties demand.

Travel

Travel is primarily local during the business day and may include the transportation of equipment. Some out-of-area and overnight travel may be expected, up to five (5) percent.

- 2. Eight (8) years of work experience performing criminal investigations, crime lab duties, and/or forensic digital analysis.
- 3. Equivalent combinations of education and experience may also be considered.

- 1. Preference may be given to applicants with current certifications through the International Association for Identification (IAI), including:

 - f. Forensic Art Certification
 - g. Tenprint Fingerprint Certification
- 2. Preference may be given to applicants with the following experience and/or certifications:
 - a. Completion of AccessData BootCamp Training
 - b. AccessData Certified Examiner (ACE)
 - c. Certification in Cellebrite and Axiom acquisition tools
 - d. Certification from other governing bodies in the field of Forensic Science
- 3. Preference may be given to applicants with considerable experience in the use of Cellebrite and/or Axiom digital acquisition tools.

Additional Eligibility Qualifications

- 1. Applicants must be an IAI Certified Crime Scene Investigator-
- Selected applicants must complete and thereafter maintain one (1) of the following IAI
 certifications during the probationary period for new hires or trial period for promoted County
 employees:
 - a. Crime Scene Analyst
 - b. Senior Crime Scene Analyst
- 3. Applicants must possess a valid driver's license and obtain a valid State of Utah driver's license within sixty (60) days of employment.
- 4. Selected applicants will be required to submit to a pre-employment drug screen and background check.
